#### ORDER LEVYING TAXES

WHEREAS, Harris County Municipal Utility District No. 217 (the "District") has bonds outstanding which are payable, in whole or in part, from ad valorem taxes; and

WHEREAS, the order or orders authorizing the issuance of such bonds authorize a levy of an ad valorem tax for the purpose of providing interest and principal payments on such bonds, while any part of said principal or interest remains outstanding and unpaid; and

WHEREAS, the voters of the District have authorized the levy of a tax to pay for maintenance expenses at an election held for such purpose; and

WHEREAS, it is necessary for the Board of Directors of the District to fix a specific rate of tax to be levied for the tax year 2024, based on the District's tax rolls for 2024 which have been prepared and certified by the Harris County Appraisal District. Now, therefore:

# BE IT ORDERED BY THE BOARD OF DIRECTORS OF HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 217 THAT:

<u>Section 1:</u> There is hereby levied an ad valorem tax of \$0.09 on each \$100 of assessed valuation of taxable property within the District, for the tax year 2024, for the purpose of providing interest and principal payments on the District's bonds.

<u>Section 2</u>: There is hereby levied an ad valorem maintenance tax of \$0.50 on each \$100 of assessed valuation of taxable property within the District for the tax year 2024, for the purpose of providing funds for the payment of operation, maintenance, and administrative expenses of the District and other purposes as allowed by law.

<u>Section 3:</u> There is hereby levied an ad valorem recreational facility tax of \$0.10 on each \$100 of assessed valuation of taxable property within the District for the tax year 2024, for the purpose of providing interest and principal payments on the District's bonds for recreational facilities as further described in Texas Water Code, Section 49.4645.

Section 4: The District's tax assessor-collector is hereby authorized to collect the taxes of the District.

<u>Section 5:</u> The taxes levied hereby shall become due and payable upon the receipt of the tax bill unless otherwise specifically provided by law and shall be paid on or before the 31<sup>st</sup> day of January, 2025. All taxes not paid before February 1, 2025, shall become delinquent on that date, and there shall be added thereto such penalties, interest, court costs, expenses of foreclosure sales, attorneys' fees and other expenses as are provided by law.
